Sanction: This meet is sanctioned by USA swimming and Indiana Swimming, Sanction#

Host: Boilermaker Aquatics

**Facility:** West Lafayette Junior/Senior High School 1105 N. Grant Street - West Lafayette, IN 47906-2400

6 lane, 25 yard pool. Water depth: 12 ft. and 4 ft. 0 in. The competition course has not been certified in accordance with 104.2.2C(4).

**Eligibility:** Swimmer(s) must be registered with USA swimming prior to the competition (202.2.9 E). Age as of December 20, 2015 shall determine the swimmer's age for the entire meet (205.2.2). \*\*\*Indiana Swimming does not process on-site athlete registration.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet.

202.5.2 At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The meet director or meet referee shall assist the athlete in making arrangements for such supervision.

202.4.9 D- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ISI rule – COACHES MUST constantly display their current USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and /or deny deck access if coach does not comply or card is no longer valid/current.

ISI rule to include USA-S 102.8.1B – In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA swimming rule 205.101.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel or below the knee and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

202.4.9 H – Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker room.

202.4.9 I– Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Warm-ups: Warm ups 8:00-8:30am. Meet starts 8:45 am

**Meet format:** All events are timed finals. Swimmers may compete in a maximum of 4 individual events. There will be no refunds for scratches. BA reserves the right to limit or combine events, use fly over starts or chase starts in order to complete the session within the allotted time as stated by USA Swimming and Indiana Swimming requirements. In the event that entries are limited, the host club must return the entry fees to the club(s) whose swimmers are not allowed to compete in the specific event(s).

**Check in:** Positive check in is required. The sign-in sheets will come down at 8:30am.

**Clerk of course:** There will be a clerk of course for the 8&under swimmers. All other swimmers will report to their lane assignments at appropriate times

Entry Format: The following must be submitted by the entry deadline: December 6<sup>th</sup> @ 6 PM

- Within 3 business days of receipt of email message, you must mail:
- Team summary report and executed release, and hold harmless agreement (included in this packet)
